Assignor CORPAK MEDSYSTEMS further agrees and covenants that it will execute or arrange for execution of such further assignment documents or other legal instruments as may be required from Assignor CORPAK MEDSYSTEMS, if any, to permit Assignee AVENT to obtain recordation as needed of any documents relating to the foregoing assignments from Assignor CORPAK MEDSYSTEMS to Assignee AVENT, including but not limited to country-specific or registration-specific assignment documents relating to the registrations and applications for registration identified on the attached Schedule A. The effective date of this assignment is December 31st, 2017.

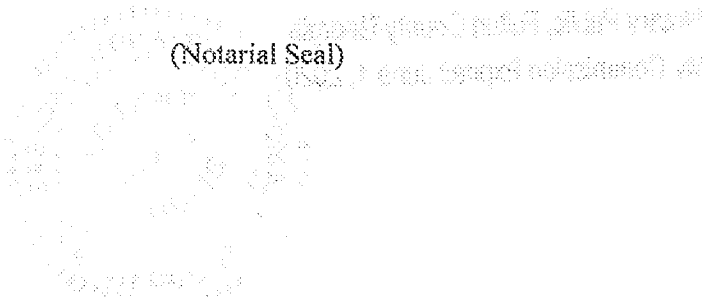


