
**RESTATED GRANT OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

THIS RESTATED GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS, dated March 23, 2018, is made by **SCRIPTFLEET, LLC**, as successor in interest to **SCRIPTFLEET, INC.** (the "Pledgor"), a Florida Limited Liability Company, in favor of **FIDUS MEZZANINE CAPITAL, L.P.**, as Collateral Agent (the "Collateral Agent");

NOW, THEREFORE, in conjunction with the security interest granted to the Collateral Agent under an Amended and Restated Pledge and Security Agreement, as amended, modified, restated or supplemented from time to time (the "Security Agreement") dated as of September 28, 2017 and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Secured Obligations (as defined in the Security Agreement), the Pledgor, as successor in interest, does hereby restate, without novation, the Grant to the Collateral Agent of a security interest in all of its right, title and interest in and to the Trademarks and the Patents, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks. The provisions of this Grant are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.
