ARTICLES OF CONVERSION

THIS IS TO CERTIFY THAT:

Article I.

Window Nation, Inc. is a Maryland corporation formed on June 21, 2006 (the "Converting Corporation") and, by virtue of these Articles of Conversion and Articles of Organization filed for the record herewith, is converting (the "Conversion") to Window Nation LLC, a limited liability company formed under the laws of the State of Maryland (the "Converted Limited Liability Company"), on the terms and conditions set forth herein.

Article II.

Upon the completion of the Conversion in accordance with the Maryland General Corporation Law ("MGCL") and the Maryland Limited Liability Company Act ("MLLCA"), the Converted Limited Liability Company shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Converting Corporation, and the Conversion will have the effects set forth herein and in the MGCL and MLLCA.

a. Each outstanding share of common stock of the Converting Corporation, without par value per share (the "Converting Corporation Common Stock"), shall, without any action on the part of any stockholder of the Converting Corporation, be converted into and exchanged for one (1) membership interest in and to the Converted Limited Liability Company, without par value.

ARTICLES OF ORGANIZATION OF
WINDOW NATION LLC

Pursuant to the Maryland Limited Liability Company Act, the undersigned, Michael T. Wyatt, whose address is 1447 York Road, Suite 800, Lutherville, Maryland 21093, being at least eighteen (18) years of age, is hereby authorized to execute these Articles and otherwise act as agent for the purpose of forming a limited liability company ("Limited Liability Company") under the Public General Laws of the State of Maryland, which Limited Liability Company shall be the Converted Limited Liability Company in accordance with certain Articles of Conversion filed by Window Nation, Inc. contemporaneously with these articles, and hereby certifies as follows:

I. Name. The name of the Limited Liability Company shall be:

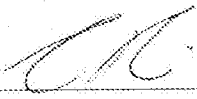

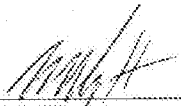
