TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of March 29, 2018, by MADISON CAPITAL FUNDING LLC, as Agent for the Lenders (the “**Bank**”).

W I T N E S S E T H:

WHEREAS, Bank and S.L. START AND ASSOCIATES LLC, a Delaware limited liability company (“**Grantor**”), were parties to that certain Trademark Security Agreement, dated as of October 31, 2017 (the “**Agreement**”; all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), and pursuant to which Grantor granted a security interest to Bank in the Trademark Collateral, including the trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office (“**PTO**”) on October 31, 2017, at Reel 6194, Frame 0092;

WHEREAS, Grantor has requested that Bank release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, Bank has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including the following:

(i) each trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of each such trademark, or (b) injury to the goodwill associated with each such trademark.

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank's right, title and interest (if any) in and to the Trademark Collateral.
