**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY  
AGREEMENT  
(Trademarks)**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (Trademarks) (this "Termination"), is dated as of March 29, 2018, and made by SILICON VALLEY BANK, a California corporation (the "Grantee"), to WEALTHCARE CAPITAL MANAGEMENT IP, LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of September 29, 2016, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on October 5, 2016 at Reel 5893 Frame 0814; and

WHEREAS, Grantor has requested that Grantee, and Grantee has agreed to, release its security interest in certain Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and Grantee hereby assigns and transfers to Grantor, without any representation, warranty, or recourse whatsoever, Grantee's entire right, title, and interest in and to the Trademarks, effective as of the date set forth above.
