The Assignor also assigns all of his right, title and interest in and to said Mark in all foreign countries, and all applications for registration of said Mark in foreign countries and any registration(s) which may evolve therefrom, including the right to claim International Convention priority

This Assignment shall be construed, interpreted and applied in accordance with the laws of the State of Pennsylvania and may be amended or modified only by a written instrument signed by each party. This Assignment may also be executed in one or more counterparts, all of which shall be considered one and the same agreement.


