**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 3, 2018 (“Release”), is made by Bank of America, N.A., as collateral agent (together with its successors, in such capacity, the “Collateral Agent”) in favor of the entities listed in Exhibit A hereto (each, a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of November 27, 2012 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) among the Grantors and the Collateral Agent, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in, among other property, all of Grantors’ right, title, and interest in and to the Trademark Collateral;

WHEREAS, pursuant to the Security Agreement, certain of the Grantors executed and delivered to the Collateral Agent, for the benefit of the Secured Parties, (i) the Trademark Security Agreement recorded in the United States Patent and Trademark Office (“USPTO”) on November 27, 2012 at reel/frame 4907/0497; (ii) the Trademark Security Agreement recorded in the USPTO on December 11, 2015 at reel/frame 5688/0193; (iii) the Trademark Security Agreement recorded in the USPTO on February 16, 2016 at reel/frame 5736/0220; and (iv) the Trademark Security Agreement recorded in the USPTO on February 19, 2016 at reel/frame 5736/0209 (collectively, the “Trademark Security Agreement”);

WHEREAS, pursuant to that certain Trademark Assignment, entered into as of February 16, 2016, Castleline Holdings, LLC (“Castleline”) transferred to Altisource Solutions S.à r.l. certain of Castleline’s rights in the Trademark Collateral (as defined in the applicable Trademark Security Agreement), which Trademark Assignment was recorded in the USPTO on February 17, 2016 at reel/frame 5733/0757; and

WHEREAS, Altisource Solutions S.à r.l. and Altisource Holdings S.à r.l. (“Holdings”) entered into a merger by absorption with Holdings surviving the merger and subsequently changing its name to Altisource S.à r.l.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Trademark Security Agreements.

SECTION 2. Termination and Release. The Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of Grantors’ right, title and interest in and under the Trademark Collateral, including, but not limited to, the trademarks and trademark applications listed on Exhibit B attached hereto; and

(b) authorizes the recordation of this Release with the United States Patent and Trademark Office at Grantors' expense.

SECTION 3. Choice of Law. This Release and the rights and obligations of the parties hereunder and any claim or controversy relating hereto shall be governed by, and construed in accordance with, the laws of the State of New York, without regard to its conflicts of laws principles.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
