**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of March 30, 2018 by SILICON VALLEY BANK (the “*Assignee*”), in favor of NINTEX PTY LTD, a proprietary limited company organized under the laws of Australia (“*Nintex*”), DRAWLOOP TECHNOLOGIES, INC., a Florida corporation (“*Drawloop*”), and OBS Pty. Ltd., a proprietary limited company organized under the laws of Australia (“*OBS*”, and together with Nintex and Drawloop, individually and collectively, jointly and severally, the “*Grantor*”).

WHEREAS, Nintex and OBS executed and delivered a Trademark Security Agreement, dated as of April 9, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Trademark Agreement*”), granting the Assignee a security interest in and lien on certain Trademark and Trademark applications (“*Trademarks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on June 10, 2014, at Reel 5299, Frame 0199;

WHEREAS, Nintex executed and delivered a Ratification and Amendment to Trademark Security Agreement, dated as of January 2, 2015 (the “*Trademark Amendment*”, together with the Trademark Agreement, the “*Grant*”), granting the Assignee a security interest in and lien on certain Trademarks described therein, which was recorded with the USPTO on January 2, 2015, at Reel 5433, Frame 0755; and

WHEREAS, Drawloop executed and delivered a Trademark Security Agreement, dated as of July 1, 2015 (the “*Drawloop Trademark*”, together with the Trademark Agreement and Trademark Amendment, the “*Grant*”), granting the Assignee a security interest in and lien on certain Trademarks described therein, which was recorded with the USPTO on July 1, 2015, at Reel 5567, Frame 0211; and

WHEREAS, Grantor has requested that the Assignee provide a document suitable for recording in the USPTO to evidence the release of the Assignee’s security interests in and liens on the Trademarks as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor’s right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those Trademarks identified in **Schedule A** hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
