ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment is made and entered into effective the 30th day of March, 2018, by Blumberg Industries, Inc., a Florida corporation (hereinafter referred to as "Assignor") to and for the benefit of GQ Investments, LLC, a Florida limited liability company (hereinafter referred to as "Assignee"), with a principal address of 5772 Miami Lakes Drive East, Miami Lakes, Florida 33014.

Assignor desires to sell, transfer, assign and set over unto Assignee, and Assignee desires to accept, all rights, title and interest in and to any and all of Assignor's intellectual property, including, but not limited to the Intellectual Property, and all of the goodwill associated with the Intellectual Property as specified in this Assignment.

NOW, THEREFORE, in consideration of the mutual covenants and agreements of the Parties contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed as follows:

(1) Assignor hereby sells, transfers, assigns and sets over to Assignee, Assignor's entire right, title and interest (for all countries) in and to any and all of its intellectual property, including any and all copyrights, common law rights, and the Intellectual Property, and all the rights and privileges under the Intellectual Property that may be granted therefor, together with the goodwill of the business associated with the Intellectual Property and other intellectual property rights of Assignor being assigned to Assignee pursuant to this Assignment.

(2) Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States as well as the Copyright Office of the United States and any other governmental agency in any other county that oversees any such Intellectual Property in such other jurisdiction to update the owner information for the Intellectual Property to reflect the Assignee as the owner of the Intellectual Property, or to such successor, assign or nominee as Assignee may designate.

(3) Assignor agrees that, at any time, upon the reasonable request of the Assignee, Assignor will execute and deliver all papers, take all rightful oaths, and do all acts which may be necessary or desirable to secure and maintain protection on the Intellectual Property throughout all countries of the world and for vesting title thereto in Assignee, its successors, assigns and legal representatives or nominees, and otherwise to do the necessary to give full effect to and to perfect the rights of the Assignee under this Assignment, including the execution, delivery and procurement of any and all further documents evidencing this Assignment, transfer and sale as may be necessary or desirable; provided, that Assignee shall reimburse Assignor for any out-of-pocket costs or expenses in connection therewith.

(4) Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.


(5) Assignor further covenants that at any time, upon the reasonable request of the Assignee, Assignee will be provided promptly with all pertinent facts and documents relating to its intellectual property, including the Intellectual Property as may be known and accessible to Assignor and will testify as to the same in any interference, litigation or proceeding related thereto and will promptly execute and deliver to Assignee, its successors, assigns and legal representatives or nominees, any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce the Intellectual Property and other intellectual property which it is assigning pursuant to this Assignment which may be necessary or desirable to carry out the purposes thereof and hereof.

(6) Assignor authorizes and empowers Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for trademark, service mark or other form of protection for the Intellectual Property, the benefit of the right of priority provided by the laws of any country or countries, or by any convention which may henceforth be substituted for it, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable, and to invoke and claim such right of priority without further written or oral authorization from Assignor.

Upon execution hereof, Assignee shall own all of the rights, interests, title and goodwill of the Intellectual Property and all of Assignor's rights to any other intellectual property which it owns related thereto.

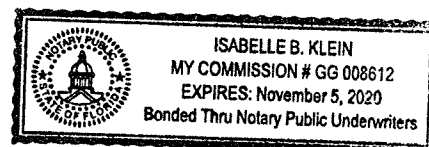
