**SECOND AMENDMENT TO  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This SECOND AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Amendment") amends and shall be considered a part of that certain Intellectual Property Security Agreement (as previously amended, the "Agreement"), dated as of April 30, 2014, entered into between WINE HOOLIGANS, LLC, a California limited liability company ("Grantor"), and COMERICA BANK ("Secured Party"), which (i) was filed and recorded with the United States Patent and Trademark Office on May 1, 2014 and was designated Reel 5272, Frame 0128 as a reference number and (ii) was amended by that certain Amendment to Intellectual Property Security Agreement, dated as of June 19, 2015, which was filed and recorded with the United States Patent and Trademark Office on October 19, 2015 and was designated Reel 5468, Frame 0062 as a reference number. 
