**TERMINATION AND RELEASE  
OF TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (this "Release"), effective April 2, 2018, is granted by Wetzlar Investments, LLC ("Wetzlar"), in favor of Norbest, LLC, and its successors, assigns, and legal representatives ("Norbest").

**Recitals**

Whereas, Norbest and Western AgCredit, PCA are parties to an Amended and Restated Master Loan Agreement, dated as of August 21, 2015, for which CoBank, ACB acts as the administrative agent (as amended, restated, supplemented, or otherwise modified from time to time, the "MLA") and an Amended and Restated Security Agreement dated August 24, 2015 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), pursuant to which Norbest granted to CoBank, ACB, in its capacity as administrative agent on behalf of Western AgCredit, PCA and CoBank, ACB, (collectively "Cobank") a security interest in all of Norbest's personal property;

WHEREAS, pursuant to the Security Agreement, Norbest and CoBank entered into a Trademark Security Agreement dated September 1, 2017, (the "Trademark Security Agreement") which was recorded with the United States Patent and Trademark Office on September 1, 2017, at Reel/Frame 6146/0497, for the purpose of collateral security for all indebtedness and obligations of Norbest under the MLA;

Whereas, pursuant to a certain Loan Sale agreement dated December 31, 2017, by and between CoBank and Wetzlar, together with its successors and assigns, CoBank assigned, conveyed, and transferred to Wetzlar all of CoBank's right, title, and interest in, to, and under the Trademark Security Agreement;

WHEREAS, Norbest has requested that Wetzlar execute this Release in order to effectuate, evidence, and record the release and reassignment to Norbest of any and all right, title, and interest Wetzlar may have in Norbest's Trademarks pursuant to the Trademark Security Agreement; and

WHEREAS, Wetzlar has agreed to terminate and release its security interest in the Trademarks identified in Schedule A attached hereto.

**Release**

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wetzlar hereby states as follows:

1. Termination and Release of Security Interest. Wetzlar hereby terminates the Trademark Security Agreement and terminates, releases, and discharges any and all security interests that it has pursuant to the Trademark Security Agreement in any and all right, title, and interest in and to all of the Trademarks of Norbest, including, without limitation, the trademarks listed on Schedule A attached hereto.

2. Further Assurances. Wetzlar agrees, at Norbest's expense, to take all further actions and to provide to Norbest and its successors, assigns, and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as Norbest and its successors, assigns, and legal representatives may reasonably request in order to confirm, effectuate, or record this Release.

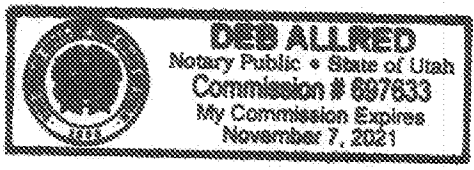
