**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "*Termination and Release*") dated as of April 4, 2018 from CAPITAL ONE BUSINESS CREDIT CORP., as successor collateral agent (the "*Collateral Agent*") pursuant a Trademark Security Agreement dated as of July 17, 2014 (the "*Security Agreement*") between ABELCONN, LLC, a Delaware limited liability company (as "*Grantor*") and CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH (the "*Predecessor Agent*"), as assigned to Collateral Agent pursuant to a Notice of Assignment of Trademark Security Agreement dated as of November 6, 2014 (the "*Notice of Assignment*").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "*Security Interest*") was granted by the Grantor to the Predecessor Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined) and such Security Interest and the Security Agreement were assigned to the Collateral Agent pursuant to the Notice of Assignment;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 22, 2014 at Reel 5366, Frame 0280;

WHEREAS, the Notice of Assignment was recorded in the Trademark Division of the United States Patent and Trademark Office on November 10, 2014 at Reel 5398, Frame 0436; and

WHEREAS, Grantor requests and the Collateral Agent is willing to terminate and release its Security Interest in the Specified Trademark Collateral as specified herein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean the Trademark Collateral (as defined in the Security Agreement), including, without limitation, each trademark registration and application set forth on Schedule I hereto.
2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.
