TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of April 9, 2018, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, (as successor in interest to General Electric Capital Corporation (“General Electric”), and in its capacity as Agent, the “Grantee”), in favor of **TOURNEAU, LLC**, a Delaware limited liability company with its principal offices at 663 Fifth Avenue, New York, New York 10022 (the “Grantor”).

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated as of September 12, 2016 (the “Trademark Security Agreement”) granting the Grantee a security interest in and lien on certain Marks (the “Granted Security Interest”);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on September 14, 2016, at Reel 005877, Frame 0233;

WHEREAS, the Grantor, the Grantee, and General Electric Capital Corporation, among others, executed that certain Assignment of Security Agreement for Trademarks, dated as of September 12, 2016 (the “Assignment Agreement”), pursuant to which General Electric transferred, conveyed, assigned, and delivered to Grantee any liens and security interests in certain Marks which it had been granted by the Grantor (the “Assigned Security Interest”, and together with the Granted Security Interest, the “Security Interest”);

WHEREAS, the Assignment Agreement was recorded in the United States Patent and Trademark Office on September 13, 2016, at Reel 005876 Frame 0048; and,

WHEREAS, the Grantee now desires to terminate and release the entirety of the Security Interest in the Marks and the Grantor has requested that the Grantee provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its Security Interest.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Marks pursuant to the Trademark Security Agreement, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby states as follows:

1. Definitions. All initially capitalized terms used but not otherwise defined herein have the meaning given to them in the Trademark Security Agreement.

2. Release of Security Interest. The Grantee hereby terminates, releases and discharges its Security Interest and any Granted Security Interest in the Marks, which are identified on Schedule 1, and any right, title or interest of the Grantee in such Marks shall hereby cease and become void.

3. Further Assurances. The Grantee hereby agrees, at the Grantor’s cost and expense, to duly execute, acknowledge, produce and deliver any further documents and to do such other

acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
