## INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment Agreement (“**Assignment**”), effective January 1, 2018, is made by and between Norbest, LLC (“**Seller**”), a Delaware limited liability company, located at 15 East 1900 South, Moroni, Utah, 84646, and Pitman Family Farms (“**Buyer**”), a California corporation, located at 1075 North Avenue, Sanger, California, 93657, the purchaser of certain assets of Seller pursuant to ASSET PURCHASE AGREEMENT, dated effective as of January 1, 2018 (“**Asset Purchase Agreement**”). Seller and the Buyer are referred to herein individually as a “**Party**” and collectively as the “**Parties**.”

WHEREAS, Seller is the owner of all right, title, and interest in and to the copyrights, domain names, tradenames, trademarks, and other intellectual property set forth on Schedule A attached hereto, including all common law rights therein and all goodwill and other intangible assets associated therewith (collectively, the “**Intellectual Property**”);

WHEREAS, under the terms of the Asset Purchase Agreement, Seller has conveyed, transferred, and assigned to Buyer, among other assets, the Intellectual Property, and has agreed to execute and deliver this Assignment, for recording with the United States Patent and Trademark Office, and the United States Copyright Office, and the corresponding entities or agencies in other applicable jurisdictions;

NOW THEREFORE, in consideration of the covenants and agreements contained herein and in the Asset Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties hereto agree as follows:

1. Assignment. The Seller hereby conveys, assigns, transfers, and delivers to the Buyer all of the Seller’s right, title, and interest in and to the Intellectual Property, together with all common law rights therein and all goodwill and other intangible assets associated therewith.

2. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns.

3. Further Assurances. The Seller and the Buyer shall execute and deliver, or cause to be executed and delivered, from time to time hereafter, upon request and without further consideration, all such further documents and instruments and shall do and perform all such acts as may be reasonably necessary to give full effect to the intent of this Assignment.

4. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Buyer with respect to the Assigned IP. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the

terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

5. Governing Law. This Assignment shall in all aspects be governed by and construed in accordance with the laws of the State of Utah, without giving effect to the principles of conflicts of law thereof.

6. Counterparts. This Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

IN WITNESS WHEREOF, the Seller and the Buyer have executed this Assignment as of the date first written above.




