**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (the "Release") is dated as of April 10, 2018 by JPMORGAN CHASE BANK, N.A., as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") in favor of CONVERGEONE, INC. ("ConvergeOne"), STRATEGIC PRODUCTS AND SERVICES, LLC ("SPS"), and PROVIDEA CONFERENCING, LLC ("Providea") and, together with ConvergeOne and SPS, the "Grantors" and each, individually, a "Grantor"). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Security Agreement.

**WITNESSETH**

WHEREAS, C1 Intermediate Corp., a Delaware corporation, C1 Holdings Corp. (f/k/a ConvergeOne Holdings Corp.), a Delaware corporation (the "Borrower"), ConvergeOne, the other subsidiaries of the Borrower from time to time party thereto and the Collateral Agent entered into that certain Guarantee and Collateral Agreement dated as of June 20, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, (i) ConvergeOne executed and delivered to the Collateral Agent that certain Trademark Security Agreement dated as of June 20, 2017 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on June 23, 2017 at Reel/Frame No. 6090/0346 and that certain Copyright Security Agreement dated as of June 20, 2017 (the "Copyright Security Agreement") and submitted to the United States Copyright Office ("USCO") on June 29, 2017 for recordation, and (ii) SPS and Providea executed and delivered to the Collateral Agent that certain Trademark Security Agreement dated as of September 22, 2017 (the "Supplemental Trademark Security Agreement" and together with the Trademark Security Agreement, the "Trademark Security Agreements") and recorded with the USPTO on October 9, 2017 at Reel/Frame Nos. 6177/0993 and 6178/0001, pursuant to which the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of its Trademark Collateral (as defined in the Trademark Security Agreements) and Copyright Collateral (as defined in the Copyright Security Agreement);

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all right, title, and interest in the Trademark Collateral and Copyright Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title or interest in or to any and all of its Trademark Collateral and Copyright Collateral, including the trademark registrations, trademark applications, and copyright registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral and Copyright Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral and Copyright Collateral under the Security Agreement, Trademark Security Agreements, and Copyright Security Agreement.





