## **RELEASE OF TRADEMARK SECURITY AGREEMENT**

WHEREAS, pursuant to that certain Trademark Security Agreement, dated April 11, 2016, recorded in the United States Patent and Trademark Office at Reel 5769, Frame 0957 on April 12, 2016 (the "TM Security Agreement"), The Retirement Plan Company, LLC ("Releasee"), created in favor of Kayne Anderson Senior Credit Advisors, LLC (in such capacity, together with its successors and permitted assigns, "Releasor"), as agent for itself and other such lending institutions as become Lenders under a certain Credit Agreement, dated as of June 11, 2013, as amended through the date hereof, a security interest in all of the Trademarks (as defined in the TM Security Agreement) set forth on Schedule 1 attached hereto, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Trademark Collateral"); and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its security interest in the Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:


1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the TM Security Agreement.

2. Release of Security Interest. Releasor hereby terminates, releases, relinquishes and discharges its security interest in the Trademark Collateral, as well as any other lien or security interest it may have in the Trademark Collateral or any other collateral of Releasee under the TM Security Agreement, the Security Agreement or other related documents.

3. Authorization. Releasor hereby authorizes Releasee or Releasee's agent to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.
