**TRADEMARK SECURITY RELEASE**

THIS TRADEMARK SECURITY RELEASE (this “Release”) is made as of March 30, 2018, by OAKTREE SPECIALTY LENDING CORPORATION (f/k/a FIFTH STREET FINANCE CORP.), a Delaware corporation, as the administrative agent for the Lenders as defined in that certain Amended and Restated Security Agreement dated May 1, 2012, as amended (together with its successors and assigns, “Agent”), in favor of HOME BRANDS GROUP HOLDINGS, INC., f/k/a AMBATH/REBATH HOLDINGS, INC., a Delaware corporation (“Holdings”), AGILE BUILDING SOLUTIONS, LLC, f/k/a AMBATH, LLC, a Delaware limited liability company (“ABS”), HOME BRANDS GROUP, LLC, a Delaware limited liability company (“HBG”), REBATH, LLC, a Delaware limited liability company (“ReBath”), and 5 DAY KITCHENS, LLC, a Delaware limited liability company (“FDK” and, together with Holdings, ABS, HBG, and ReBath, jointly and severally, individually and collectively, “Assignor”).

**WITNESSETH:**

WHEREAS, reference is made to: (a) that certain Trademark Collateral Assignment and Security Agreement dated as of December 30, 2009, and recorded at the United States Patent and Trademark Office on July 7, 2017, at Reel 6101, Frame 0020, (b) that certain Notice of Grant of Security Interest in Trademarks dated as of May 1, 2012, and recorded at the United States Patent and Trademark Office on May 2, 2012, at Reel 4770, Frame 0349, (c) that certain Notice of Grant of Security Interest in Trademarks dated as of October 9, 2012, and recorded at the United States Patent and Trademark Office on October 24, 2012, at Reel 4888, Frame 0159, and (d) that certain Notice of Grant of Security Interest in Trademarks dated as of January 23, 2017, and recorded at the United States Patent and Trademark Office on February 3, 2017, at Reel 5980, Frame 0820 (collectively, the “Security Agreement”; capitalized terms which are not defined herein have the meanings given to such terms in the Security Agreement), pursuant to which Assignor granted to Agent for the benefit of Agent and the Lenders, a continuing security interest in the Trademarks (including among other things, the Trademark registrations and Trademark applications set forth on Exhibit A attached hereto; collectively, the “Trademark Collateral”);

WHEREAS, Assignor has requested that Agent release its continuing security interest in the Trademark Collateral; and

WHEREAS, Agent has agreed to terminate and release the entirety of its continuing security interest in and to the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

1. Agent hereby terminates, cancels, and releases its continuing security interest in all of Assignor’s right, title, and interest in and to the Trademark Collateral.

2. Agent hereby releases and conveys to Assignor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title, and interest that it may have obtained in and to the Trademark Collateral, and does hereby authorize Assignor (personally or through its counsel, agents, or designees, and at Assignor’s sole expense) to take all actions reasonably necessary to release and terminate any and all security interests and other liens in the Trademark Collateral. If and to the

extent Agent has acquired any right, title, or interest to any of the Trademarks or the goodwill associated therewith, it hereby assigns and transfers such rights, title, or interest to Assignor.

3. Agent shall take all further actions, reasonably acceptable to Agent, and provide to Assignor and each of its successors, assigns, or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Assignor, each at Assignor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.


