**RELEASE OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (the "Release") is effective this 29th day of March, 2018, by and between Prince Erachem Inc. (f/k/a Erachem Comilog, Inc.) ("Erachem") and ABC Funding, LLC, as agent for itself and the other Secured Parties (as that term is defined in the Security Agreement referenced below) (the "Agent").

WHEREAS, Erachem entered into a Credit Agreement, Security Agreement and a Notice of Security Interest in Trademarks (the "Trademark Security Agreement") with the Agent and other parties thereto, each dated June 2, 2017;

WHEREAS, pursuant to said agreements, Erachem pledged, hypothecated, delivered and collaterally assigned to the Agent, and created in favor of the Agent, a security interest in all its right, title, and interest to the Trademark Collateral, among other collateral;

WHEREAS, the Notice of Security Interest in Trademarks was recorded in the United States Patent and Trademark Office (the "USPTO") on June 2, 2017 at Reel 6076, Frame 0276; and

WHEREAS, the Agent desires to terminate the Trademark Security Agreement and release its security interest in and to the Trademark Collateral pledged, hypothecated, delivered and collaterally assigned pursuant to the Credit Agreement, Security Agreement and Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent agrees as follows:

Section 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Trademark Security Agreement.

Section 2. Release of Security Interest. The Agent, without recourse, hereby (a) terminates the Trademark Security Agreement, (b) releases, relinquishes and discharges its security interest in and to the Trademark Collateral, including the trademarks listed at **Attachment A** and (c) reassigns, transfers and conveys any and all rights, title and interests it may have in such Trademark Collateral to Erachem.


Section 3. Further Assurances. The Agent hereby authorizes Erachem or its authorized representative (or their respective designees) to (i) record this Release with the USPTO and/or (ii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to Erachem any and all further documents and instruments, and do any and all further acts which Erachem (or their agents or designees) reasonably request (at Erachem's sole cost and expense) in order to confirm this Release and Erachem's right, title and interest in, to and under the Trademark Collateral.

Section 4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

IN WITNESS WHEREOF, the Agent has caused this **RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** to be executed by its duly authorized officer as of the date and the year above written.
