**SECURITY AGREEMENT**

**(TRADEMARKS)**

WHEREAS, ORCHESTRATE, LLC, an Iowa limited liability company (the "Grantor"), has adopted, used and is using the trademarks listed opposite the Grantor's name on the annexed Schedule 1, annexed hereto as part hereof, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Grantor is obligated to PNC BANK, NATIONAL ASSOCIATION, as agent for the below-defined Lenders ("Grantee"), and the other Secured Parties, as defined in the Revolving Credit, Term Loan and Security Agreement, dated as of April 20, 2015 (the "Loan Agreement"), by and among APPEXTREMES GROUP HOLDINGS, LLC, a Delaware limited liability company, APPEXTREMES, LLC, a Delaware limited liability company doing business as Conga, NOVATUS, LLC, a Delaware limited liability company and CRMCULTURE, LLC, a Delaware limited liability company, Grantor, the Persons which are now or which hereafter become a lender thereunder (collectively, the "Lenders" and each individually a "Lender"), and Grantee for the payment and performance of the Obligations (as defined in the Loan Agreement); and

The Grantor does hereby further acknowledge and affirm that the rights and remedies of Grantee with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.






