**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of October 13, 2017 (“Effective Date”) in favor of LOUD TECHNOLOGIES, INC., a Washington corporation (“US Borrower”), MACKIE DESIGNS INC., a Washington corporation (“Mackie”), SIA SOFTWARE COMPANY, INC., a New York corporation (“SIA”), SLM HOLDING CORP., a Delaware corporation (“SLM Holding”), ST. LOUIS MUSIC, INC., a Missouri corporation (“SLM” and, together with US Borrower, Mackie, SIA and SLM Holding, collectively with their respective successors and assigns, jointly and severally, the “2007 Grantors” and each individually a “2007 Grantor”), MARTIN AUDIO HOLDINGS LIMITED (formerly known as GRACE ACQUISITIONCO LIMITED) (“Martin Holdings” and, together with US Borrower, SLM and Mackie, collectively with their respective successors and assigns, jointly and severally, the “2014 Grantors” and each individually a “2014 Grantor”; the 2014 Grantors, together with the 2007 Grantors, collectively with their respective successors and assigns, jointly and severally, “Grantors” and each individually a “Grantor”), by ABLECO FINANCE LLC, a Delaware limited liability company (“Ableco”) as Collateral Agent (as defined in each Trademark Security Agreement described below, together with its successors and assigns, if any, in such capacities “Secured Party”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the applicable Security Agreement referred to below.

**WHEREAS**, Secured Party and the 2007 Grantors entered into that certain Security Agreement dated March 30, 2007 (the “Prior Security Agreement”);

**WHEREAS**, Secured Party and the 2014 Grantors entered into that certain Amended and Restated Security Agreement dated May 30, 2014 (the “A&R Security Agreement” and, together with the Prior Security Agreement, the “Security Agreements” and each a “Security Agreement”);

**WHEREAS**, Secured Party and the 2007 Grantors entered into that certain Trademark Security Agreement, dated as of March 30, 2007 (the “2007 Trademark Security Agreement”), which 2007 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 02, 2007 at Reel 03512, Frame 0808;

**WHEREAS**, Secured Party and the 2014 Grantors entered into that certain Supplemental Trademark Security Agreement, dated as of May 30, 2014 (the “2014 Trademark Security Agreement” and, together with the 2007 Trademark Security Agreement, the “Trademark Security Agreements” and each a “Trademark Security Agreement”), which 2014 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 30, 2014 at Reel 005292, Frame 0712;

**WHEREAS**, pursuant to the terms of the Security Agreements and the Trademark Security Agreements, Grantors granted to Secured Party a continuing security interest in and to the Trademark Collateral (as defined below);

**WHEREAS**, the Secured Party wishes to release, retransfer and re-assign to each applicable Grantor, without representation or warranty, all of the Secured Party's right, title or interest in, to and under the Trademark Collateral, and the goodwill associated therewith.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Grantors hereby agree as follows:

1. All capitalized terms used but not otherwise defined herein have the meanings given to them in the applicable Security Agreement.

2. The term "Trademark Collateral" means (a) all of each Grantor's Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule I hereto; (b) all goodwill, trade secrets, proprietary or confidential information, technical information, procedures, formulae, quality control standards, designs, operating and training manuals, customer lists, and other General Intangibles with respect to the foregoing; (c) all reissues, continuations or extensions of the foregoing; (d) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and (e) all products and proceeds of the foregoing, including, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under any Intellectual Property License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Intellectual Property License.

3. Secured Party hereby (a) terminates each Trademark Security Agreement, (b) terminates, cancels, releases and forever discharges any and all security interests it has against the Trademark Collateral, and (c) re-assigns and retransfers, without representation or warranty and without recourse, any right, title and interest it may have in, to and under the Trademark Collateral to the relevant Grantor.

4. Secured Party authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry or government office necessary to effect the release of its security interest in the Trademark Collateral.

5. Secured Party represents and warrants that: (a) it has the full power and authority to execute this Release; and (b) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral.
