**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 29, 2017 (“Release”), is made by Saratoga Investment Corp. SBIC LP, as Agent (“Agent”) in favor of Damballa, Inc., a Delaware corporation (“Grantor”).

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of December 1, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Grantor, Agent, and others party thereto, and the Trademark Security Agreement dated as of October 7, 2016 by and among the Grantor and Agent (“Trademark Security Agreement”), Grantor granted to Agent for its benefit and for the ratable benefit of each other Secured Party, holder of any Obligations and Lenders, a continuing security interest in and to and Lien on all of its Trademark Collateral; and

WHEREAS, , the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on October 10, 2016 at Reel 5896 Frame 0132.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of itself and each other Secured Party, holder of any Obligations and Lenders, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Agent, on behalf of itself and each other Secured Party, holder of any Obligations and Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in and to and Lien on Grantor’s Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
