RELEASE OF
SECURITY INTEREST

This Release of Security Interest (this "Release") is made and effective as of December 29, 2017, by Silicon Valley Bank ("Bank") in connection with the Security Agreement referred to below.

RECITALS

WHEREAS, pursuant to that certain (a) Amended and Restated Loan and Security Agreement, dated as of the Effective Date, as defined therein (as amended, restated or otherwise modified from time to time, the "Loan and Security Agreement"), between Tango Management Consulting, Inc., a Delaware corporation ("Grantor"), as borrower, and Bank, as lender, and (b) Intellectual Property Security Agreement, dated as of August 4, 2017 (as amended, restated, or otherwise modified from time to time, the "IP Security Agreement"), and together with the Loan and Security Agreement, collectively, the "Security Agreements", and each, a "Security Agreement"; capitalized terms used herein and not otherwise defined herein shall have the respective meanings set forth in the Security Agreements), Grantor has mortgaged, pledged, assigned, hypothecated, and granted liens and security interests in favor of Bank on all of Grantor's right, title and interest in and to the Intellectual Property Collateral, including, without limitation, the Trademarks referred to on Schedule A attached hereto (the "Scheduled Trademarks"), as collateral security for the prompt and complete payment and performance when due of the obligations of Grantor under the Loan and Security Agreement; and

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office in Trademark Reel 006156, Frame 223 on September 18, 2017; and

WHEREAS, the obligations pursuant to the Loan and Security Agreement have been satisfied and Bank no longer claims an interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby agrees as follows:

Release and Reassignment of Security Agreements

Bank hereby releases and discharges all liens on and security interests in, and hereby reassigns any and all right, title and interest to, the Intellectual Property Collateral, including without limitation, the Scheduled Trademarks and related rights and property.
