## RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Release*”) is made effective as of March 30, 2018, by Vegas HR Private Limited (the “*Secured Party*”) and HRHH IP, LLC and HRHH Hotel/Casino, LLC (each a “*Grantor*” and collectively “*Grantors*”).

WHEREAS, the Secured Party and Grantors entered into that certain Amended and Restated Intellectual Property Security Agreement, dated as of March 1, 2011 (the “*Amended and Restated Intellectual Property Security Agreement*”) and that additional Trademark Security Agreement, dated as of March 31, 2016 (the “*Trademark Security Agreement*”), and that certain Security Agreement between Column Financial Inc., and HRHH IP, LLC dated as of February 2, 2007 (the “*Column Security Agreement*”) (collectively, the “*IP Security Agreements*”), together whereby the Grantors granted to the Secured Party a security interest in and to certain intellectual property of the Grantors;

WHEREAS, the Amended and Restated Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on March 28, 2011 at Reel 4507 and Frame 0791;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on April 5, 2016 at Reel 5765 and Frame 0204;

WHEREAS, the Column Security Agreement was recorded in the United States Patent and Trademark Office on February 8, 2007 at Reel 3478 and Frame 0199;

WHEREAS, in accordance with the provisions of the IP Security Agreements, the Secured Party now desires to release its security interest in and to the Collateral (as this term is defined in the IP Security Agreements).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

SECTION 1. Defined Terms. Each capitalized term used but not defined in this Release has the meaning given or ascribed to it in the IP Security Agreements.

SECTION 2. Release of Grant of Security. The Secured Party hereby (i) terminates the IP Security Agreements and (ii) terminates, releases and discharges its security interest in, and reassigns to Grantors, all right, title and interest in and to the Collateral, including all right, title or interest in or to the Trademarks, including without limitation:

- (a) the United States trademark applications and registrations of Grantors listed on Schedule A attached hereto;
- (b) all goodwill associated therewith or symbolized thereby;
- (c) all assets, rights and interests that uniquely reflect or embody the Trademarks; and

(d) the Grantors' licenses to United States trademark applications and registrations listed on Schedule B attached hereto;

SECTION 3. Recordation. The Secured Party hereby authorizes Grantors or any of their authorized representatives to file this Release with the United States Patent and Trademark Office or any other applicable governmental office. The Secured Party hereby further authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 4. Further Assurances. The Secured Party hereby agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Grantors, at Grantors' expense, to fully effectuate the purposes of this Release.

SECTION 5. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.


