**OMNIBUS ASSIGNMENT OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

This OMNIBUS ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Assignment**”) dated April 9, 2018, is made by Deutsche Bank AG New York Branch, as withdrawing administrative agent (in such capacity, the “**Existing Administrative Agent**”), The Bank of New York Mellon, as new administrative agent for the Secured Parties (as defined in the Security Agreement referred to below) (in such capacity, the “**Successor Administrative Agent**”), Jason Incorporated, a Wisconsin corporation (the “**Borrower**”), Metalex Corporation, an Illinois corporation (“**Metalex**”, and together with Jason, the “**Grantors**”), as successor by merger of Morton Manufacturing Company, an Illinois corporation, with and into Metalex with Metalex surviving the merger.

WHEREAS, the Borrower, the guarantors from time to time party thereto (the “**Guarantors**”), the various lenders from time to time party thereto (the “**Lenders**”), the Existing Administrative Agent and the other parties thereto are party to that certain First Lien Credit Agreement, dated as of June 30, 2014 (as amended, restated, supplemented and/or otherwise modified to but excluding the date hereof, the “**Credit Agreement**”);

WHEREAS, in connection with the Credit Agreement, the Borrower, the Guarantors and the Existing Administrative Agent entered into that certain First Lien Security Agreement, dated as of June 30, 2014 (as amended, restated, supplemented and/or otherwise modified to but excluding the date hereof, the “**Security Agreement**”);

WHEREAS, the Existing Administrative Agent, the Successor Administrative Agent and the Borrower and the Guarantors are entering into a resignation and assignment agreement, dated as of the date hereof (the “**Resignation and Assignment Agreement**”);

WHEREAS, as a condition precedent to the making of Loans, the issuance of Letters of Credit by the Lenders under the Credit Agreement and the entry into Swap Agreements by Lenders or Affiliates of Lenders from time to time, each Grantor has executed and delivered or is otherwise a party to that certain (i) Patent Security Agreement, dated as of June 30, 2014, which the Existing Administrative Agent represents was recorded at the United States Patent and Trademark Office (“**USPTO**”) at reel 033257 frame 0056, reel 033449 frame 0248 and reel 033257 frame 0848; (ii) Patent Security Agreement, dated as of March 11, 2015, which the Existing Administrative Agent represents was recorded at the USPTO at reel 035428 frame 0937; (iii) Copyright Security Agreement, dated as of June 30, 2014, which the Existing Administrative Agent represents was recorded at the United States Copyright Office (“**USCO**”) as copyright number V9913 D586 P 1-9; (iv) Trademark Security Agreement, dated as of June 30, 2014, which the Existing Administrative Agent represents was recorded at the USPTO at reel 5312 frame 0460, reel 5312 frame 0506, and reel 5312 frame 0644; (v) Patent Security Agreement, dated as of June 1, 2017, which the Existing Administrative Agent represents was recorded at the USPTO at reel 042630 frame 0628; and (vi) Trademark Security Agreement, dated as of June 1, 2017, which the Existing Administrative Agent represents was recorded at the USPTO at reel 006078 frame 0692 (each of the foregoing six agreements, as amended, amended

and restated, supplemented or otherwise modified from time to time, an “**IP Security Agreements**”).

WHEREAS, pursuant to the IP Security Agreements, the Existing Administrative Agent, as the prior administrative agent, was granted or otherwise acquired a security interest in each Grantor's right, title and interest in, to and under the Patent Collateral, Copyright Collateral, Trademark Collateral (as defined in each of the IP Security Agreements) (such Collateral under the IP Security Agreements, collectively, the “**IP Collateral**”), including the IP Collateral set forth on **Schedules A, B and C** attached hereto, (collectively, the “**Security Interest**”); and

WHEREAS, consistent with the Resignation and Assignment Agreement, the Successor Administrative Agent is desirous of acquiring, and the Existing Administrative Agent is desirous of assigning, all of the Existing Administrative Agent’s right, title and interest in, to and under the IP Security Agreements, including, without limitation, the Security Interest, and all documents relating thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Existing Administrative Agent, the Successor Administrative Agent and the Grantors hereby covenant and agree as follows:

Section 1 Defined Terms. All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement.

Section 2 Assignment of IP Security Agreement. The Existing Administrative Agent hereby assigns, transfers and conveys (without recourse, representation or warrant of any kind) to the Successor Administrative Agent for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the IP Security Agreements and the IP Collateral, including, without limitation, the Security Interest, effective as of the date hereof. The Successor Administrative Agent hereby accepts the foregoing assignment.

Section 3 Security Agreement. The Security Interest assigned to the Successor Administrative Agent as the new administrative agent for the Secured Parties pursuant to this Assignment, has been granted in conjunction with the security interest granted pursuant to the Security Agreement, and the Grantors hereby acknowledge and affirm that the rights and remedies of the Successor Administrative Agent with respect to the security interest in the IP Collateral made and granted by the IP Security Agreements are more fully set forth in the Security Agreement (as amended, amended and restated, supplemented or otherwise modified from time to time as of and after the date hereof), the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


Section 4 Counterparts. This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

Section 5 Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York.
