**ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION**

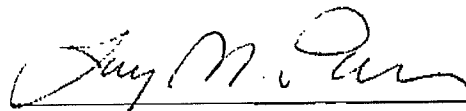
Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation.

1. The name of the corporation is Meadowbrook Meat Company, Inc.
2. The Articles of Incorporation of the corporation are hereby amended by deleting Article 1 in its entirety and substituting the following Article 1 in lieu thereof:  
  
“1. The name of the corporation is McLane Foodservice Distribution, Inc.”
3. The foregoing amendment was duly adopted by the Board of Directors and approved by the sole shareholder of the corporation as required by Chapter 55 of the North Carolina General Statutes on November 10, 2017.

These articles will become effective January 1, 2018.
