THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "*Termination and Release*") dated as of March 30, 2018, from PLEXUS FUND III, L.P., as Agent (the "*Agent*") pursuant to a Notice of Grant of Security Interest in Trademarks (the "*Notice of Grant*") dated as of August 26, 2016 among IC REAL TECH, INC., a Delaware corporation, IC REALTIME, LLC, a Delaware limited liability company, IC REALTIME WEST COAST, LLC, an Arizona limited liability company, WESTECH DEVELOPMENT GROUP, INC., a Nevada corporation, M2M ADVISORS LLC, a Nevada limited liability company and CLEARVIEW CCTV, LLC, a Nevada limited liability company, (each a as "*Grantor*" and collectively, the "*Grantors*"), and the Agent.

WITNESSETH:

WHEREAS, pursuant to the Notice of Grant a security interest (the "*Security Interest*") was granted by the Grantors to the Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Notice of Grant was recorded in the Trademark Division of the United States Patent and Trademark Office on September 8, 2016 at Reel 5877, Frame 0412; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean all of each Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications set forth on Schedule I hereto.


