## **NOTICE OF RELEASE OF SECURITY INTEREST**

This Notice of Release of Security Interest (the "Release") is effective as of April 14, 2017, by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as agent for the Lenders ("Agent") under the Revolving Credit and Security Agreement dated as of May 20, 2014 ("Credit Agreement") in favor of **NATIONAL LABEL COMPANY**, a Delaware corporation, and **JAMES LICENSING COMPANY**, a Delaware corporation (each a "Grantor", and collectively the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement.

WHEREAS, pursuant to the Credit Agreement and the Patent and Trademark Security Agreement dated as of May 20, 2014 ("IP Security Agreement") by the Grantors in favor of Agent, the Grantors granted to Agent for its benefit and the benefit of the Lenders a continuing security interest in and Lien on all of Grantors' right, title and interest in, to and under the IP Collateral (as defined in the IP Security Agreement), including the IP Collateral set forth on Exhibit A attached hereto; and


WHEREAS, the IP Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on May 21, 2014 at Reel/Frame 5284/0309, and with the patent division of the United States Patent and Trademark Office on May 21, 2014 at Reel/Frame 032972/0144;

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Credit Agreement and IP Security Agreement, Agent hereby releases and remits, without any recourse, representation or warranty, the continuing security interest in and Lien on all of Grantors' right, title and interest in, to and under the IP Collateral (as defined in the IP Security Agreement), including the IP Collateral set forth on Exhibit A attached hereto, granted pursuant to the Credit Agreement or IP Security Agreement, and hereby authorizes the Grantors or Grantors' authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release.
