

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby grants, sells, assigns and transfers all right, title and interest in and to the KICAO Mark and the KICAO Registration, including but not limited to all common law rights associated therewith together with the goodwill arising from the use of and symbolized by the mark, and all of Assignor's rights therein, including the right to pursue legal action for past infringement thereof, and related damages.
