

CORRECTION BY DECLARATION**

This Correction by Declaration is being provided to correct the Change of Name (hereafter, "Name Change") recorded at the United States Patent and Trademark Office on October 25, 2017 on Reel 6189 and Frame 0481, whereby Women's Capital LCC is the conveying party and Women's Capital LLC is the receiving party. This Name Change was erroneous filed by Women's Capital LLC in attempt to correct a typographical error it made in a previously filed Change of Name recorded at the United States Patent and Trademark Office on September 12, 2017 on Reel 6152 and Frame 0354. In the original Change of Name filed on September 12, 2017, the conveying party made an obvious typo in the name of the receiving party indicating that the receiving party was Women's Capital LCC and not Women's Capital LLC, and failed to indicate the conveying party's state of incorporation.

The undersigned hereby affirms that a Corrective Assignment was filed with the United States Patent and Trademark Office on January 24, 2018 having ETAS ID TM459193 to correct the Change of Name filed on September 12, 2017 at the United States Patent and Trademark Office on Reel 6152 and Frame 0354 to reflect a Change of Name from conveying party, Women's Capital Corporation, a Delaware Corporation, to receiving party, Women's Capital LLC, a Delaware limited liability company.
