TRADEMARK SECURITY RELEASE

THIS RELEASE dated as of April 6, 2018 (this "Release") is made by RB Trademark Holdco, LLC, a Delaware limited liability company, acting in its capacity as agent (in such capacity, the "Agent") under a certain Trademark Security Agreement dated as of June 30, 2013 (the "Trademark Security Agreement") by Larsen and Bowman Holdings Ltd., a British Columbia corporation (the "Grantor") and the Agent, entered into in connection with a certain Acquisition Agreement dated as of June 30, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), made by the Grantor in favor of the Agent. Terms defined in the Trademark Security Agreement and not otherwise defined herein are used herein as defined in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Agent a continuing first priority security interest in and to all of such Grantors' right, title and interest in, to the Collateral including, but not limited to:

- (a) The Trademarks, including but not limited to the trademark and service mark registrations, applications and licenses set forth in Schedule 1 attached hereto, all reissues, continuations, extensions, modifications and renewals of the foregoing, along with all goodwill of the business connected with the use of and symbolized by the foregoing (the "Released Collateral");
- (b) Any and all claims for damages for past, present and future infringement, misappropriation or breach with respect to the Trademarks, with the right, but not the obligation to sue for and collect, or otherwise recover such damages; and
- (c) Any and all proceeds of the foregoing.

WHEREAS, the Grantors have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office, Canadian Intellectual Property Office, and other applicable government offices evidencing and effecting the release, relinquishment and discharge of its security interest in the Released Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, (i) terminate the liens and security interest created under the Trademark Security Agreement and the Security Agreement in the Released Collateral, (ii) release its security interest in the Released Collateral, and (iii) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Released Collateral. Agent acknowledges that this Release may be filed along with other necessary documentation with the United States Patent and Trademark Office, the Canadian Intellectual Property Office or any other governmental office to evidence the release granted herein.
