## **RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of April 10, 2018 (this “Release”) is made by MEDLEY CAPITAL CORPORATION, a Delaware Corporation, acting in its capacity as administrative agent (in such capacity, the “Agent”) under that certain Trademark Security Agreement, dated as of September 11, 2014 (as amended, supplemented or modified and in effect from time to time, the “Trademark Security Agreement”) by and among the Grantors listed on the signature pages thereof (each, a “Grantor” and collectively, the “Grantors”) and the Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on September 22, 2014 at reel 5366, frame 0294, each Grantor granted to the Agent a continuing security interest in all of such Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A (the “Trademark Collateral”);

WHEREAS, the Grantors have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral. The Agent agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantors to evidence the release and termination of the Agent's security interests in the Trademark Collateral.


