GLOBAL TRADEMARK ASSIGNMENT

This GLOBAL TRADEMARK ASSIGNMENT (this “**Assignment**”) is effective as of January 31, 2013 (the “**Effective Date**”) by and among The Dow Chemical Company, a Delaware corporation (“**TDCC**”)¹, and PMC Cincinnati, Inc., a Delaware corporation with its principal place of business at 1288 Route 73, Suite 401, Mt. Laurel, New Jersey 08054 (“**ASSIGNEE**”).

BACKGROUND

WHEREAS, TDCC and ASSIGNEE entered into an Asset Purchase Agreement dated as of November 13, 2012 (“**Asset Purchase Agreement**”), whereby TDCC agreed to sell, assign, transfer and convey certain assets, including Trademarks (as defined below), to ASSIGNEE;

WHEREAS, PMC Parent (as defined in the Asset Purchase Agreement) has agreed pursuant to Section 11.3 of the Asset Purchase Agreement to guarantee all of the obligations of ASSIGNEE hereunder;

WHEREAS, Rohm and Haas Chemicals, LLC (“**ASSIGNOR**”), a wholly owned subsidiary of TDCC, is the registered owner of certain trademarks;

WHEREAS, ASSIGNOR is selling, assigning, transferring and conveying certain assets to ASSIGNEE including, without limitation, all of ASSIGNOR’s right, title and interest in the trademarks listed on the attached Schedule A (herein defined as “**TRADEMARKS**”) and ASSIGNEE is purchasing such assets; and

WHEREAS, ASSIGNOR has authorized TDCC to act as agent on behalf of ASSIGNOR in connection with the transfer to the ASSIGNEE of any TRADEMARKS.

TERMS

NOW THEREFORE, in consideration of the above premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intent to be legally bound, the parties hereto hereby agree as follows:

Effective as of the Effective Date, and on the terms and subject to conditions of the Asset Purchase Agreement, ASSIGNOR hereby sells, assigns, transfers and conveys all of its right, title and interest in and to all TRADEMARKS together with the goodwill of the business which they represent symbolized by the TRADEMARKS, including all associated trademark rights, service mark rights, trade name rights, and other indicia of origin, held by ASSIGNOR, together with all registrations and applications for registration of the TRADEMARKS, all claims, demands and rights to recovery that ASSIGNOR has or may have for future infringements, dilution or other violations of such TRADEMARKS, if any, and all rights to compromise, sue for, and collect on such claims, demands and rights to recovery. TDCC represents and warrants that (i) it has the full power and authority to enter into

this Assignment and (ii) ASSIGNOR has authorized TDCC to act as agent on behalf of ASSIGNOR in connection with the transfer to ASSIGNEE of any TRADEMARKS.

ASSIGNOR, on behalf of itself, its successors, assigns and legal representatives, hereby authorizes the U.S. Patent and Trademark Office and any official of any country or countries foreign to the United States whose duty it is to receive or register trademarks or applications therefor, to record ASSIGNEE as the owner of the TRADEMARKS, and to issue all registrations for the foregoing, to be in the name of ASSIGNEE, for the sole use of ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this Assignment. ASSIGNOR (on behalf of itself, its successors, assigns and legal representatives) and ASSIGNEE shall each promptly take, and shall cause their respective Affiliates to take, any and all additional actions as may be necessary or appropriate to effect the assignment transactions contemplated, including but not limited to execution and delivery of individual assignment documentation for filing with the authorities of each individual country. The responsibility to file assignments with the national trademark offices of each country shall be on the ASSIGNEE and the ASSIGNEE shall bear the cost of filing such assignments.

Promptly following the Effective Date, ASSIGNOR will transfer to ASSIGNEE any files for the TRADEMARKS. ASSIGNOR may retain copies of such files solely for use in providing any assistance requested by the Company pursuant to this Assignment.
