2. **RIGHTS AND OBLIGATIONS:**

- a. Assignor agrees to execute and deliver, or cause to be executed and delivered, to Assignee or any purchaser of the Trademarks from Assignee, any and all documents and instruments, in form and substance reasonably satisfactory to Assignee and its counsel, necessary or useful or which may become necessary or useful to effect and complete the transfer, grant or sale to Assignee of all rights or property acquired or intended to be acquired by Assignee under this Assignment and shall pay any fees or expense necessary for such transfer, grant or sale, found due and owing prior to the date of this Assignment.
- b. To the extent that Assignee is unable to obtain Assignor's signature for the execution of the documents and instruments specified in Sections 2(a), above, Assignor irrevocably constitutes and appoints Assignee as its true and lawful representative and attorney-in-fact, with full power and authority in its name, place and stead, to execute such documents and instruments on behalf of Assignor. The foregoing grant of authority is a special power of attorney coupled with an interest, shall be irrevocable and shall continue in full force and effect
