2. On December 3, 2017, an individual named Duanke Wong submitted a Change of Name Assignment with the USPTO Assignment Recordation Branch for PROVIDER, Reg. No. 3977440 (the "Change of Name").
3. The Change of Name was recorded by the USPTO Assignment Recordation Branch as Reel/Frame 6219/0039.
4. The Change of Name indicated that Trans-Texas Tire, LLC changed its name to "SHANDONG LINGLONG TYRE CO., LTD." on December 3, 2017.
5. The Change of Name is incorrect as Trans-Texas Tire, LLC has not changed its name to "SHANDONG LINGLONG TYRE CO., LTD."
6. The correct name for Trans-Texas Tire, LLC is still Trans-Texas Tire, LLC.
7. The Texas Comptroller of Public Accounts database shows Trans-Texas Tire, LLC as an active entity in the state of Texas and has not changed its name. A true and correct copy of a printout from the Texas Comptroller of Public Accounts website showing the status of Trans-Texas Tire, LLC is attached as Exhibit 1 to this declaration.
8. Trans-Texas Tire, LLC is not the same entity as SHANDONG LINGLONG TYRE CO., LTD.

9. The previously recorded Change of Name should not be considered against the registration for PROVIDER, Reg. No. 3977440, as Trans-Texas Tire, LLC has not changed its name and is not the same entity as SHANDONG LINGLONG TYRE CO., LTD.
