RELEASE AND TERMINATION OF TRADEMARK SECURITY AGREEMENT

This RELEASE AND TERMINATION OF TRADEMARK SECURITY AGREEMENT (this "Release") is executed as of April 16, 2018 by JPMORGAN CHASE BANK, N.A., as successor by merger with The Chase Manhattan Bank, N.A. ("Chase Bank" or the "Secured Party").

WHEREAS, Continental Airlines, Inc., a Delaware corporation (together with its successors and assigns, the "Grantor"), granted and pledged to the Secured Party, a security interest in all of the Grantors' right, title and interest in, to and under certain trademarks listed on Schedule I hereto and proceeds thereof (collectively, the "Trademark Collateral");

WHEREAS, evidence of the security interest in the Trademark Collateral were filed by the Secured Party against the Grantor with such filings having been recorded by the United States Patent and Trademark Office on (a) August 4, 1997, in Reel 1618, at Frame 0600 and (b) October 15, 1997, in Reel 1656, at Frame 0790; and

WHEREAS, such security interest has been terminated, and in connection with such termination, the Secured Party has agreed to release its security interest in all of the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby:

A. releases the liens and security interests granted by the Grantor to the Secured Party in the Trademark Collateral pursuant to any security agreement (collectively, the "Trademark Security Agreement"), including without limitation each item of Trademark Collateral listed on Schedule I hereto;

B. to the extent the Secured Party shall be deemed to have any right, title or interest in, to and under any item of Trademark Collateral held by the Grantor, retransfers and reassigns to the Grantor all of such right, title and interest with respect to any such item of Trademark Collateral, including each item of Trademark Collateral listed on Schedule I hereto; and

C. terminates each Trademark Security Agreement entirely with respect to the Grantor.

D. authorizes the Grantor (or any designee of the Grantor) to file any necessary UCC termination and other applicable termination statements (including filings at the United States Patent and Trademark Office) in connection with this Release.

The Secured Party agrees to execute and deliver promptly to the Grantor such documents as the Grantor shall reasonably request to evidence the release of liens and security interests contemplated hereby.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REFERENCE TO CONFLICT OF LAWS PRINCIPLES.
