BILL OF SALE AND IP ASSIGNMENT AGREEMENT

This BILL OF SALE AND INTELLECTUAL PROPERTY ASSIGNMENT (this "*Agreement*") is entered into as of January __, 2018, by and between Alco Capital Group, Inc., as Assignee for the Benefit of Creditors (the "*Assignee*" or "*Seller*") of Homeclick, LLC (the "*Company*"), and Belami, Inc., a California corporation ("*Purchaser*").

RECITALS

WHEREAS, the Company was engaged in the business of selling and marketing, direct to consumers, of various goods for use in the home ("*Business*");

WHEREAS, in early November 2017, the Company ceased normal operations, and, on November 3, 2017, the Company assigned all of its assets to Seller pursuant to the terms of a Deed of Assignment for the Benefit of Creditors of Homeclick LLC ("*Assignment*");

WHEREAS, on November 6, 2017, the Assignment was received by the Superior Court of New Jersey, Chancery Division, Probate Part Middlesex County (the "*Court*"), designated as *In re: Assignment for the Benefit of Creditors of Homeclick, LLC*, Docket No. 259048 ("*Assignment Case*");

WHEREAS, the Assignee is in the process of liquidating the Company's assets and, in connection with such efforts, have conducted a process to sell the assets described herein;

WHEREAS, Seller intends to seek an order approving the Agreement in the Assignment Case;

WHEREAS, Seller wishes to sell to Purchaser, and Purchaser wishes to acquire from Seller, the Purchased Assets (as defined below), subject to the terms and conditions set forth in this Agreement; and

WHEREAS, Seller and Purchaser agree that the transactions proposed herein are the product of good faith, arm's-length negotiations between Seller and Purchaser.

NOW, THEREFORE, in consideration of the mutual promises in this Agreement and for other good and valuable consideration, the parties hereby agree as follows.

AGREEMENT

1. Definitions

In addition to terms defined throughout the agreement, the following terms shall have the meanings ascribed to them in this Section 1:

1.1 "*Other Acquired Assets*" means all Other Assets except Excluded Documents.

1.2 “*Confidential Information*” means all written or oral information, disclosed by either party to the other, related to the operations of either party or a third party that has been identified as confidential or that by the nature of the information or the circumstances surrounding disclosure ought reasonably to be treated as confidential.

1.3 “*Other Assets*” means (a) all books, records, files, invoices, inventory records, product specifications, customer-related information, correspondence with actual or prospective customers and suppliers, cost and pricing information, supplier lists, business plans, personnel records, catalogs, customer literature, quality control records and manuals and credit records of customers (b) Marketing Accounts, and (c) Marketing Materials, including all data and other information stored on hard drives (including those located on remote servers), discs, tapes or other media.

1.4 “*Excluded Documents*” means all Other Assets prepared in connection with this Agreement or primarily relating to the Assignment Case, all minute books, corporate records (such as stock registers) and organizational documents of the Company, and all other Documents not related to the Business.

1.5 “*Homeclick Customer*” means any individual or entity that has purchased goods or services from the Company or submitted contact information to the Company for the purpose of receiving communications regarding the Business.

1.6 “*Homeclick IP*” means all Homeclick Property, and associated IP Rights, that are owned or purported to be owned by Seller, and are or were used in connection with or related to the Business prior to the Closing.

1.7 “*Homeclick Licensed IP*” means any licenses to IP Rights that are or were used in connection with or related to the Business prior to the Closing.

1.8 “*Homeclick Property*” means all discoveries, ideas, business plans, concepts, improvements, inventions (whether patentable or not), knowledge, know-how, processes, information, data, data collections, procedures, processes, techniques, designs, drawings, flow charts, software code (in any form including source code and executable or object code), user interface, wire frames, formulae, computer programs, trade secrets, works of authorship, Trademarks and services marks, and any licenses corresponding to any of the foregoing, used in connection with or related to the Business.

1.9 “*IP Rights*” means, on a worldwide basis, any and all IP rights under any law or regulation, including: (a) rights associated with works of authorship, including copyrights, moral rights and mask-works; (b) Trademarks; (c) trade secret rights; (d) patents, designs, algorithms and other industrial property rights; (e) other intellectual and industrial property rights of every kind and nature, however designated, whether arising by operation of law, contract, license or otherwise (including pursuant to unfair competition law, publicity rights law, or privacy rights law); and (f) registrations, applications, renewals, extensions, continuations, continuations-in-part, divisionals, restorations, reissues, reexaminations, on any of the foregoing.

1.10 “*Marketing Accounts*” means any and all marketing tools and accounts, including, without limitation, Google AdWords, Google Analytics, Shopzilla, NexTag, Pricegrabber, Shopping.com, Amazon, Bing, CJ, and Criteo accounts held by or for the Company and used for or related to the Business, including any and all of the following used in connection with such accounts: (a) account information, profiles, pages, feeds, registrations and other presences; and (b) account name(s), user name(s), administrative control(s), password(s), log-in information and credentials, and other identifiers registered or used by or on behalf of the Company.

1.11 “*Marketing Materials*” means all marketing materials, marketing research data, customer and sales information, product literature, promotional materials and data, advertising and display materials (including all underlying designs, samples, charts, diagrams, photos and electronic files related to the foregoing) and all training materials, in each case in whatever form or medium (e.g., audio, visual, digital or print) held in the Company's name and related to the Business.

1.12 “*Purchased Assets*” means the Homeclick IP, Homeclick Licensed IP, Customer Information, Social Media Accounts, Servers, Other Acquired Assets, Marketing Accounts, and Marketing Materials.

1.13 “*Social Media Accounts*” means any and all social media accounts, including, without limitation, Instagram, YouTube, Facebook, and Twitter accounts held by or for the Company and used for or related to the Business, including any and all of the following used in connection with such accounts: (a) account information, profiles, pages, feeds, registrations and other presences (including mobile and fixed web presences); and (b) account name(s), user name(s), nickname(s), display name(s), handle(s), administrative control(s), password(s), log-in information and credentials, and other identifiers registered or used by or on behalf of the Company.

1.14 “*Trademarks*” means all trademarks, service marks, trade dress, trade names, brand names, logos, trade dress, corporate names, domain names and other similar designations of source, sponsorship, association or origin, together with the goodwill symbolized by any of the foregoing, in each case whether registered or unregistered and including all registrations and applications for, and renewals and extensions of, such rights and all similar or equivalent rights or forms of protection.

2. Purchase and Sale

2.1 Sale, Transfer, Assignment, Delivery and Conveyance of Purchased Assets. Effective upon the consummation of the Closing, Seller shall absolutely, unconditionally and irrevocably sell, transfer, assign, deliver and otherwise convey to Purchaser, and Purchaser does hereby purchase, acquire and accept from Seller, all of Seller's rights, title and interest, to the Purchased Assets, including all Homeclick IP throughout the world, including any goodwill symbolized thereby, whether tangible or intangible, and in any form or medium, whether now known or existing or hereafter developed, together with all rights of action and defenses accrued, accruing and to accrue in respect thereof, including without limitation the right to sue or otherwise recover for past infringement and to receive all damages, payments, costs and fees

associated therewith and to fully and entirely stand in the place of Seller and/or the Company in all matters related to all of the foregoing (collectively, the “*Assigned IP*”), in each case free and clear of any encumbrances (which for purposes of this Section 2.1, will mean any lien, pledge, mortgage, deed of trust or security interest). Seller and Company hereby waive any moral rights, or rights equivalent thereto, that Seller may have in or to the Assigned IP worldwide and any such rights in or to any underlying works which exclusively or primarily relate to the Assigned IP, in each case without compensation or the need for further action by any third party. To the extent that the foregoing waiver is ineffective under applicable law, Seller agrees that it will not assert such moral rights against Purchaser or any third party. This foregoing assignment is intended to be an absolute assignment and not a security interest.

2.2 Transfer of Social Media Accounts. Effective upon the consummation of the Closing, Seller shall transfer to Purchaser all of Seller’s right, title and interest in and to the Social Media Accounts, including any and all information that Seller can lawfully transfer and to which the Company had reasonable access regarding relationships, interactions and communications with, users, viewers, commenters, fans and/or subscribers of such Social Media Accounts (including users who have “liked,” “friended,” “followed” or otherwise expressed support for such Social Media Account (using a mechanism offered by the operator of the platform for such Social Media Account)). Seller shall take all steps necessary to promptly transfer ownership of such Social Media Accounts, and if such transfer is not possible, to migrate the content and data from the affected Social Media Account(s) to new social media account(s) designated by Purchaser.

2.3 Copies. Effective upon the consummation of the Closing, Seller shall transfer to Purchaser all of Seller’s right, title and interest in and to one (1) master copy of any software components of the Homeclick IP, in both source code and object code form, and any other copies of Homeclick Licensed IP in Seller’s possession or control that it can deliver subject to the terms of its license to such Homeclick Licensed IP, all in accordance with Purchaser’s reasonable instructions.

2.4 Customers. Effective upon the consummation of the Closing, Seller shall sell, transfer, assign, convey and deliver, or cause to be sold, transferred, assigned, conveyed and delivered, to Purchaser, and Purchaser shall purchase, all right, title and interest of Seller in all information collected by or on behalf of the Company relating to Homeclick Customers that is in Seller’s possession or control (the “*Customer Information*”) and shall take all actions necessary to ensure the prompt transfer to Purchaser of the Customer Information.

2.5 Servers. Effective upon the consummation of the Closing, Seller shall sell, transfer, assign, convey and deliver, or cause to be sold, transferred, assigned, conveyed and delivered, to Purchaser, and Purchaser shall purchase, all right, title and interest of Seller in any and all servers owned by the Company (the “*Servers*”).

2.6 Other Acquired Assets. Effective upon the consummation of the Closing, Seller shall sell, transfer, assign, convey and deliver, or cause to be sold, transferred, assigned, conveyed and delivered, to Purchaser, and Purchaser shall purchase, all right, title and interest of Seller in the Other Acquired Assets (to the extent transferrable), and Seller shall take all actions necessary to ensure the prompt transfer to Purchaser of the Acquired Other Assets,

provided that, to the extent any intangible Other Acquired Assets cannot be transferred to Buyer, Seller shall be deemed to have granted to Buyer an exclusive, royalty-free right and license to use such intangible Other Acquired Assets from and after the Closing, to the fullest extent permitted by applicable law and the underlying agreements, as applicable.

2.7 Exhibit. Without limiting the foregoing or anything else in this Agreement, attached hereto as Exhibit A are schedules identifying any and all Trademarks and domain names being sold to Purchaser under this Agreement.

2.8 Further Authorization. Effective upon the consummation of the Closing, Seller hereby authorizes and requests the Commissioner of Patents of the United States, the Commissioner of Trademarks of the United States, the Librarian of Congress of the United States and any other official of any applicable governmental entity worldwide and each registrar of a domain name or web site included in the Purchased Assets, to record all registrations and applications for registration included in the Purchased Assets in the name of Purchaser and issue any and all registrations from any and all applications for registration included in the Purchased Assets to and in the name of Purchaser. Following the Closing, Seller agrees to execute such documents as Purchaser may reasonably request to fully effectuate the transfer of the Purchased Assets to Purchaser as set forth herein.

2.9 Closing. Subject to the terms and conditions of this Agreement, including the termination of this Agreement pursuant to Section 4.2 hereof, the consummation of the sale of the Purchased Assets (the "*Closing*") shall take place on (i) the date that is the first (1st) Business Day following the date as of which all of the conditions set forth in Section 3 hereof have been satisfied or waived (except for such conditions that, by their terms, are to be satisfied at the Closing, but subject to the satisfaction or waiver of each such condition), or (ii) such other date as the parties hereto agree in writing. The date on which the Closing actually occurs is referred to herein as the "*Closing Date*". The parties hereto agree that the Closing shall be deemed effective as of such time as Seller shall have received payment of the Purchase Price (as defined below). As used in this Agreement, "*Business Day*" means any day other than a Saturday, Sunday, or other day on which commercial banks in New Jersey are required or authorized by law to be closed.

2.10 Purchase Price and Payment.

(a) The consideration to be paid and delivered at the Closing by Purchaser and accepted by Seller for the Purchased Assets shall be a cash amount equal to three hundred and seventy-five thousand dollars (\$375,000.00) (the "*Purchase Price*").

(b) Upon the execution of this Agreement, Purchaser shall wire a deposit to Seller in the amount of thirty-seven thousand five hundred dollars (\$37,500) (the "*Deposit*"), which shall be held in trust by Seller separate from other funds until the Closing or until the Deposit is otherwise disposed of as provided hereunder. The Deposit shall not be subject to any lien, attachment, trustee process, or any other judicial process of any creditor of Seller or Company.

(c) At the Closing, Purchaser shall pay the Purchase Price to Seller by (i) release to Seller of the Deposit and (ii) wire transfer of immediately available funds to such account(s) as Seller shall designate in writing in an amount equal to the Purchase Price minus the Deposit. All liens that existed on the Purchased Assets as of the date of the Closing shall attach to the proceeds of sale to the same extent and in the same priority as existed as of the date of the Closing.

2.11 Approval of the Court. Seller shall seek approval of the transactions contemplated by this Agreement by the Court.

3. Conditions Precedent to Closing.

3.1 Conditions Precedent to Obligations of Purchaser. The obligation of Purchaser under this Agreement to consummate the transactions contemplated by this Agreement on the Closing Date shall be subject to the satisfaction, at or prior to the Closing Date, of all of the following conditions, any one or more of which may be waived by Purchaser:

(a) Approval of the Court. The Court shall have approved the consummation of the transactions contemplated by this Agreement in a manner acceptable to both Purchaser and Seller, each in their sole and absolute discretion.

(b) No Legal Prohibition. No injunction, order, decree or judgment shall have been issued and be in effect or threatened to be issued by any governmental entity of competent jurisdiction, and no statute, rule or regulation shall have been enacted or promulgated by any governmental entity and be in effect, which in each case restrains or prohibits the consummation of the transactions contemplated hereby.

(c) Deliveries. Seller shall make all deliveries at Closing reasonably requested by Purchaser, in a form reasonably satisfactory to Purchaser.

(d) Performance. Seller and Company will have performed and complied in all material respects with all the covenants, agreements, and obligations required to be performed or complied with by any of them before or on the Closing Date under this Agreement.

(e) No Material Adverse Effect. There will have been no material adverse effect on the Purchased Assets from the date hereof through the Closing Date.

3.2 Conditions Precedent to Obligations of Seller. The obligation of Seller under this Agreement to consummate the transactions contemplated by this Agreement on the Closing Date shall be subject to the satisfaction, at or prior to the Closing Date, of all of the following conditions, any one or more of which may be waived by Seller:

(a) Approval of the Court. The Court shall have approved the consummation of the transactions contemplated by this Agreement in a manner acceptable to both Purchaser and Seller, each in their sole and absolute discretion.

(b) No Legal Prohibition. No injunction, order, decree or judgment shall have been issued and be in effect or threatened to be issued by any governmental entity of competent jurisdiction, and no statute, rule or regulation shall have been enacted or promulgated by any governmental entity and be in effect, which in each case restrains or prohibits the consummation of the transactions contemplated hereby.

(c) Deliveries. Purchaser shall make all deliveries at Closing reasonably requested by Seller, in a form reasonably satisfactory to Seller.

4. Miscellaneous

4.1 Terms of Transaction. Seller represents and warrants to Purchaser that Seller has good and marketable title to the Purchased Assets and has the right to sell, assign, transfer, convey and deliver to Purchaser, free and clear of any and all liens, claims, or encumbrances, all of Seller's right, title, and interest in and to the Purchased Assets, as well as all of Seller's duties, obligations, or liabilities to be performed or arising on or after the Closing in connection with the Purchased Assets. Seller makes no other representations or warranties whatsoever, express or implied, with respect to any matter relating to the Purchased Assets, including, without limitation, the merchantability or fitness of the Purchased Assets (or any portion thereof) for any particular purpose. Without in any way limiting the forgoing, SELLER HEREBY DISCLAIMS ANY WARRANTY (EXPRESS OR IMPLIED) OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE AS TO ANY PORTION OF THE PURCHASED ASSETS. Purchaser acknowledges and agrees that Purchaser is purchasing the Purchased Assets based solely upon Purchaser's independent investigation with respect to the Purchased Assets and, accordingly, Purchaser shall accept the Purchased Assets "AS IS," "WHERE IS," and "WITH ALL FAULTS." Purchaser represents and warrants to Seller that (i) Purchaser has all necessary right, power, and authority to enter into, execute, deliver and perform this Agreement, without the need for any further approval of its officers or governing body, (ii) this Agreement constitutes the valid and legally binding obligation of Purchaser enforceable against Purchaser in accordance with its terms, (iii) no consent of any third party is required to be made or obtained by Purchaser in connection with the execution, delivery, and performance of this Agreement and the consummation of the transactions contemplated hereby, and (iv) Purchaser's obligation to effect the Closing is not subject to any condition, including any financing or due diligence condition, other than as expressly set forth in Article 3 hereof.

4.2 Termination and Effect.

(a) This Agreement may be terminated, and the transactions contemplated herein may be abandoned, at any time before the Closing:

- (i) by mutual written agreement of Seller and Purchaser;
- (ii) by Seller if Seller agrees to an alternative sale, transfer, or other disposition of all or any portion of the Purchased Assets in one or more transactions with one or more person other than Purchaser;

(iii) by Seller, on the one hand, or Purchaser, on the other hand, in the event of a material breach hereof by Seller, on the one hand, or Purchaser, on the other hand, if such non-terminating party fails to cure such breach within five (5) Business Days following notification thereof by the terminating party;

(iv) by Purchaser by the delivery of a written notice of termination to the other party, if the Closing has not occurred on or prior to February 16, 2018, and such failure of the Closing to occur is not the result of an uncured material breach of this Agreement by the Purchaser;

(v) by Purchaser by the delivery of a written notice of termination to Seller, if any of the conditions in Section 3.2 has not been satisfied by February 16, 2018.

(b) Effect of Termination. If this Agreement is validly terminated pursuant to this Section 4.2, subject to the provisions of this Section 4.2(b), this Agreement will forthwith become null and void, and there will be no liability or obligation on the part of any party hereto (or any of their respective officers, directors, employees, partners, agents or other representatives or affiliates), except that the provisions of this Article 4 shall survive any such termination. Notwithstanding anything in this Agreement to the contrary:

(i) if Seller and Purchaser terminate this Agreement pursuant to Section 4.1(a)(i), Seller terminates this Agreement pursuant to Section 4.2(a)(ii), or Purchaser terminates this Agreement pursuant to Section 4.2(a)(iii), 4.2(a)(iv), or 4.2(a)(v), Purchaser shall receive the prompt return of the Deposit; and

(ii) if Seller terminates this Agreement pursuant to Section 4.2(a)(iii), Seller shall be entitled to keep the Deposit, which shall be Seller's sole and exclusive remedy.

4.3 Expenses. Each party hereto shall pay its own expenses incurred in connection with this Agreement and the transactions contemplated hereby.

4.4 Brokerage. To the best of the Company's knowledge, there are no claims for brokerage commissions, finders' fees or similar compensation in connection with this Agreement or the transactions contemplated hereby based on any arrangement or agreement made by or on behalf of the Company. Any and all claims of the nature described in this paragraph that existed as of the date of Closing (or after said transaction has Closed) shall attach to the proceeds of the sale and shall only be satisfied (if at all) from the proceeds of sale. The Parties agree that Purchaser has no knowledge of or responsibility for any potential claims described in this section 4.4.

4.5 Court Approval. Until the earlier of (x) the Closing or (y) the termination of this Agreement in accordance with Section 4.2, Seller will use commercially reasonable efforts to obtain the Court's approval ("Court Approval") of this Agreement and the transactions contemplated therein as soon as reasonably practicable. Seller shall provide copies of all motions and other filings to Seller, and any proposed order effectuating Court Approval must be acceptable to Purchaser in its discretion.

4.6 Name Change. Immediately after the Closing Date, the Company will cease use of the name “Homeclick” and any derivatives thereof and the Seller will file an amendment to the Company’s Certificates of Incorporation changing its name, and will file a pleading to change the Company’s name on the docket in the Court.

4.7 Operation of Company’s Business. Until the earliest of (x) the Closing and (y) the termination of this Agreement in accordance with Section 4.2, Seller, except as consented to by the Buyer, such consent not to be unreasonably withheld, conditioned or delayed:

- (a) shall operate the Business in all material respects as it exists on the date hereof and use commercially reasonable efforts to preserve the Purchased Assets; and
- (b) shall not: transfer, lease, license, sell, abandon, terminate, create any encumbrance on or otherwise dispose of any of the Purchased Assets.

4.8 Confidentiality. Except to the extent required to be publicly filed in the Assignment Case, Seller and Company agree to (and to cause their respective employees, contractors, representatives, and agents to) treat confidentially and not to disclose to any person (unless such person needs to know such information for the purpose of pursuing and consummating the transactions contemplated in this Agreement) Confidential Information, and to not use Confidential Information in any manner or for any other purpose, except in connection with pursuing or consummating the transactions contemplated in this Agreement. Notwithstanding anything to the contrary in this Section 4.8, if Seller or Company are requested or required to disclose Confidential Information, Seller and Company will promptly notify Purchaser and will afford Purchaser the opportunity to obtain a protective order or other appropriate remedy to maintain the confidentiality of the Confidential Information. If a protective order or other remedy is not available, Seller and Company will furnish only the portion of Confidential Information that Purchaser is advised in writing by its counsel that it is legally required to furnish and will use commercially reasonable efforts to obtain, prior to disclosure, assurances that confidential treatment will be given thereto.

4.9 Further Assurance. From time to time after the Closing Date, without further cost or expense to Purchaser, Seller and Company will take, and cause their affiliates and other persons under their direction or control to take, such further actions as Purchaser may reasonably request to more effectively transfer to and vest unencumbered title in Purchaser and to put Purchaser in possession of the Purchased Assets.

4.10 Entire Agreement; Interpretation. The terms and conditions of this Agreement constitute the entire agreement between the parties hereto with respect to the subject matter hereof, and supersede all prior and contemporaneous agreements, understandings, negotiations and discussions. None of the parties hereto shall be bound by any conditions, definitions, warranties, understandings, or representations with respect to the subject matter hereof other than as expressly provided herein. The section headings contained in this Agreement are for reference purposes only and shall not affect in any way the meaning or interpretation of this Agreement. No oral explanation or oral information by any party hereto shall alter the meaning or interpretation of this Agreement. The terms “includes” and “including” are not

limiting. Unless a contrary intention is indicated, (i) the words “herein”, “hereof” and “hereunder” and other words of similar import refer to this Agreement as a whole and not to any particular Article, Section or other subdivision, and (ii) reference to any Article or Section means such Article or Section hereof. The parties hereto have participated jointly in the negotiation and drafting of this Agreement. In the event an ambiguity or question of intent or interpretation arises, this Agreement shall be construed as if drafted jointly by the parties hereto, and no presumption or burden of proof shall arise favoring or disfavoring any party hereto by virtue of the authorship of any of the provisions of this Agreement.

4.11 Notices: All notices required or permitted to be given hereunder shall be in writing, shall make reference to this Agreement, and shall be delivered (i) by hand, (ii) dispatched by prepaid air courier or by registered or certified airmail, postage prepaid, or (iii) sent via electronic mail (with a copy dispatched by prepaid air courier for delivery on the next Business Day), in each case, addressed as follows:

This Agreement may be executed in one or more counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement, and any such executed counterpart may be delivered by transmission of the manually signed document by facsimile transmission or in "pdf" form delivered by electronic mail, and such facsimile or "pdf" representation of such manual signature shall constitute execution thereof.

4.13 Survival of Representations, Warranties, and Covenants. All of the representations and warranties of the parties hereto set forth in this Agreement shall terminate upon the consummation of the Closing. All of the covenants of the parties hereto set forth in this Agreement shall survive until fully performed.

4.14 Amendment. This Agreement may not be amended or modified except by an instrument in writing signed by, or on behalf of, Seller and Purchaser.

4.15 Severability. Any provision of this Agreement which is prohibited or unenforceable in any jurisdiction shall not invalidate the remaining provisions hereof, and any such prohibition or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction, and any such provision, to the extent invalid or unenforceable, shall be replaced by a valid and enforceable provision which comes closest to the intention of the parties hereto underlying such invalid or unenforceable provision.

4.16 Waivers. Waiver by any party hereto of any breach of or failure to comply with any provision of this Agreement by any other party shall not be construed as, or constitute, a continuing waiver of such provision, or a waiver of any other breach of, or failure to comply with, any other provision of this Agreement. No waiver of any such breach or failure or of any term or condition of this Agreement shall be effective unless in a written notice signed by the waiving party and delivered, in the manner required for notices generally, to each affected party.







INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (the "*IP Assignment*"), dated as of February 14, 2018, is entered into by and among ALCO CAPITAL GROUP, INC., a New Jersey corporation (the "*Assignor*") and Belami, INC., a California corporation (the "*Assignee*").

RECITALS:

WHEREAS, pursuant to the terms and conditions of a Bill of Sale and IP Assignment Agreement, dated as of January 26, 2018 (the "*Bill of Sale and Assignment Agreement*"), by and between the Assignor, Assignee and the other parties thereto, the Assignor wishes to sell, transfer, convey, assign and deliver to the Assignee, and the Assignee has agreed to acquire and accept, all of the Assignor's right, title and interest in and to the intellectual property owned by Assignor, as the Assignee for the Benefit of Creditors of Homeclick, LLC (the "*IP Assets*"), all on the terms and subject to the conditions set forth in the Bill of Sale and Assignment Agreement (capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Bill of Sale and Assignment Agreement);

WHEREAS, the Assignee wishes to acquire, and the Assignor wishes to transfer all right, title and interest in and to the IP Assets of the Assignor;

WHEREAS, in connection with the Closing, Assignee and Assignor have entered into the Bill of Sale and Assignment Agreement pursuant to which, among other things, the parties consummated the sale, conveyance, assignment, transfer and delivery to Assignee of the Purchased Assets including the IP Assets of the Assignor; and

WHEREAS, Assignor and Assignee now desire to enter into this IP Assignment for the purpose of recording the sale, conveyance, assignment, transfer and delivery to Assignee of the IP Assets of the Assignor with any applicable Governmental Entity worldwide.

NOW, THEREFORE, for good and valuable consideration, including the consideration set forth in the Bill of Sale and Assignment Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignment. Assignor hereby irrevocably sells, assigns, transfers, conveys and delivers to Assignee without any restrictions, limitations or reservations, and Assignee hereby accepts the sale, assignment, transfer, conveyance and delivery of, all of Assignor's right, title and interest in and to the IP Assets, including, without limitation:

(a) the Trademarks listed on Exhibit A and all IP Rights associated therewith;
and

(b) the domain names and web sites (including all sub-domains and related URLs) listed on **Exhibit B**;

(c) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; and

(d) any and all rights to the IP Assets included in the Purchased Assets.

2. Authorization. Assignor hereby authorizes and requests the Commissioner of Patents of the United States, the Commissioner of Trademarks of the United States, the Librarian of Congress of the United States and any other official of any applicable Governmental Entity worldwide and each registrar of a domain name or web site set forth in **Exhibit B**, to record all registrations and applications for registration included in such IP Assets in the name of Assignee and issue any and all registrations from any and all applications for registration included in such IP Assets to and in the name of Assignee.

3. Further Assurances. The Assignor agrees to execute all documents necessary to perfect, register, and/or record this IP Assignment and the rights of the Assignee to the IP Assets as the Assignee reasonably deem appropriate provided, however, that the Assignee shall not be obligated to pay any material consideration or incur any material costs in connection therewith. If the Assignor does not, within five (5) business days of presentment by the Assignee of documents necessary to register the transfer to the Assignee of the rights of the Assignor in and to the IP Assets, execute and return such documents to the Assignee, then the Assignee is hereby granted a limited power of attorney to execute such documents on behalf of the Assignor. This power of attorney is coupled with an interest and is irrevocable.

4. Interpretation. This IP Assignment has been executed and delivered by the Assignor for the purpose of recording the sale, conveyance, assignment, transfer and delivery to Assignee of the IP Assets with any applicable Governmental Entity worldwide. This IP Assignment is intended to implement the provisions of the Bill of Sale and Assignment Agreement, is expressly subject to the terms and conditions thereof, and shall not be construed to enhance, extend or limit the representations and warranties, rights, obligations or remedies of any party thereunder. In the event of any conflict or inconsistency between the terms of this IP Assignment and the terms and conditions of the Bill of Sale and Assignment Agreement, the terms and conditions of the Bill of Sale and Assignment Agreement, as the case may be, shall govern.

5. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.




