TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is made as of December 28th, 2017 (the "Effective Date") between PLAN B DESIGN LLC, a Washington limited liability company, ("Assignor") and ACTIVE SPORTS, INC., a Minnesota corporation, ("Assignee"), 7452 236th St. E., Lakeville, MN 55044.

2. Trademark registration of CTRL, WIPO EU Registration No. 1068708;
3. The goodwill of the business relating to the products and services on which the marks are used and for which they are registered;
4. All income, royalties and damages hereafter due or payable to Assignor with respect to the marks, including, without limitation, damages, and payments for past or future infringements and misappropriations of the mark; and
5. All rights to sue for past, present and future infringement of the marks.

The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the mark and its related property.
