RESOLVED, that the Amended and Restated Certificate of Incorporation of the Corporation be amended so that Article I thereof shall read in its entirety as follows:

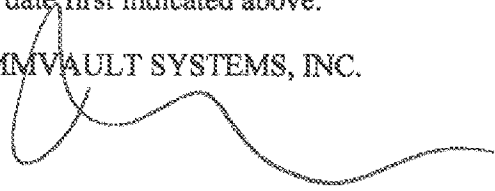
"The name of the Corporation is Commvault Systems, Inc."
