ASSIGNMENT OF TRADEMARKS



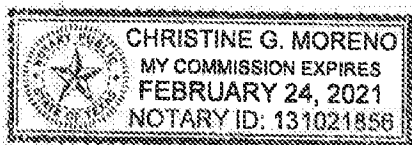


