RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of 23 April 2018 (“Effective Date”) by and between OCM FIE, LLC, a Delaware Limited Liability Company, with its principal office at 333 South Grand Avenue, 28th Floor, Los Angeles CA 90071 (“Grantee”), and QS Wholesale, LLC, a California limited liability copmany and DC Shoes, Inc., a California corporation, (each a “Grantor” and together the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain INTELLECTUAL PROPERTY SECURITY AGREEMENT by and between Grantors and Grantee dated February 11, 2016 (the “Trademark Security Agreement”), each Grantor granted to Grantee a continuing security interest in and to all of such Grantor’s right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, (collectively, the “Trademarks”), including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto, together with the goodwill associated therewith;

WHEREAS, Grantors and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement by and between Grantors and Grantee dated February 11, 2016 (the “Security Agreement”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on March 04, 2016, at Reel 005746, Frame 0319;

WHEREAS, each Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests liens and any other right that may have been granted to Grantee in and to the Trademarks, including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto and all goodwill associated therewith.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, in each case owned by either Grantor other than those Trademarks set forth on Schedules A (attached hereto), in any jurisdiction throughout the world.

Grantee shall take all further actions, and provide to each Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by such Grantor to more fully and effectively effectuate the purposes of this Release. Grantee authorizes and requests that the PTO note and record the existence of this Release.


