OF  
SECURITY INTEREST  
IN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Termination and Release") dated as of April 25, 2018 from **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Agent"), to Grantors listed on the Schedule I hereof (collectively, jointly and severally, "Grantors" and each individually "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain (a) Trademark Security Agreement dated January 15, 2013 in favor of the Agent, for the benefit of the Lender Group and the Bank Product Providers (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time prior to the date hereof, the "2013 Trademark Agreement"), (b) Notice of Grant of Security Interest in U.S. Trademarks dated as of May 7, 2015 in favor of the Agent, for the benefit of the Lender Group and the Bank Product Providers (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time prior to the date hereof, the "2015 Trademark Agreement"), and (c) Amended and Restated Trademark Security Agreement by and between the Grantors and the Agent dated June 8, 2016 in favor of the Agent, for the benefit of the Lender Group and the Bank Product Providers (as amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the "2016 Trademark Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in the Trademark Collateral, including Trademarks identified on Exhibit A attached hereto (as hereinafter defined);

WHEREAS, the 2013 Trademark Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (the "USPTO") on February 08, 2013 at Reel 4959, Frame 0033; the 2015 Trademark Agreement was recorded in the USPTO on May 8, 2015 at Reel 5512 and Frame 0633; and the 2016 Trademark Agreement was recorded in the USPTO on July 1, 2016 at Reel 5826, Frame 0818;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees and acknowledges as follows:

1. Definitions. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Guaranty and Security Agreement or, if not defined therein, in the Credit Agreement, and this Termination and Release shall be subject to the rules of construction set forth in Section 1(b) of the Guaranty and Security Agreement, which rules of construction are incorporated herein by this reference, mutatis mutandis.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, including the Trademarks identified on Exhibit A attached hereto and made a part hereof, and assigns to the Grantors, without recourse, all of the Agent's right, title and interest in the Trademarks, and any right, title or interest of the Agent in such Trademark shall hereby


cease and be void. Agent understands and agrees that this Agreement may be recorded by or for the Grantors with the USPTO or any similar office or agency.

3. Further Assurances. Upon request by the Grantors, the Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the Security Interest contemplated hereby.
