With and Into
CBC AMERICAS CORP. (a Delaware corporation)

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law (the "DGCL"), the undersigned corporation executed the following Certificate of Merger.

FIRST: The name and state of incorporation of each of the constituent corporations is as follows: CBC AMERICAS CORP., a Delaware corporation (the "Delaware Company"), and CBC AMERICAS CORP., a New York corporation (the "New York Company").

SECOND: The Agreement of Merger, dated as of February 19, 2018, by and between the Delaware Company and the New York Company (the "Merger Agreement"), setting forth the terms and conditions of the merger of the New York Company with and into the Delaware Company (the "Merger") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations, by the Delaware Company in accordance with the DGCL and by the New York Company in accordance with New York Business Corporation Law (the "NYBCL").

THIRD: The New York Company filed its Certificate of Incorporation with the Secretary of State of New York on April 10, 1979, pursuant to the provisions of the NYBCL.

FOURTH: The Delaware Company filed its Certificate of Incorporation with the Secretary of State of Delaware on February 16, 2018, pursuant to the provisions of the DGCL.

FIFTH: The Delaware Company is the surviving corporation in the Merger (the "Surviving Corporation"), and the name of the Surviving Corporation is CBC AMERICAS CORP.

SIXTH: The Certificate of Incorporation of the Delaware Company, as in effect immediately prior to the Merger, shall be the Certificate of Incorporation of the Surviving Corporation until amended and changed pursuant to the DGCL.

SEVENTH: The Merger is to become effective on February 20, 2018.

EIGHTH: The executed Merger Agreement is on file at 2000 Regency Parkway, Suite 600, Cary, North Carolina 27518, the place of business of the Surviving Corporation.

NINTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation on request, without cost, to any stockholder of either constituent corporation.

TENTH: The authorized capital stock of the New York Company is 200 shares of common stock, no par value per share.
