Terms and Conditions

1. Assignor hereby sells, assigns and transfers to Assignee all of Assignor's right, title and interest in and to the Assignor Trademark throughout the universe in any typeface, stylization, colors, and/or capitalization, and any US state, federal or foreign applications and registrations of the foregoing, including the Assignor Registration, including the goodwill associated therewith and that portion of Assignor's business to which the Assignor Trademark relates (altogether, the "Assignor Trademark Rights").
2. Assignor acknowledges receipt of adequate consideration.
3. The parties hereto are separate and independent legal entities. Nothing herein contained will be construed or deemed hereby to create a principal/agent relationship between the parties nor any form of partnership or joint venture.
4. This Agreement may be executed in two or more counterparts each of which shall be deemed an original but both of which together shall constitute one and the same instrument.




