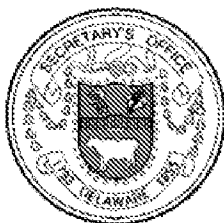

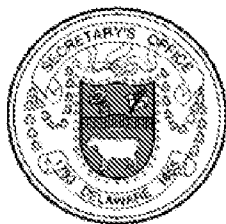

The undersigned, acting as the Organizer of a limited liability company under the Delaware Limited Liability Company Act, as amended (the "Act"), hereby adopts this Certificate of Formation for Duck Covers, LLC (the "Company"), to be effective as of the date filed with and approved by the Delaware Secretary of State.

**ARTICLE I**  
**NAME**

The name of the Company is Duck Covers, LLC.

**ARTICLE II**  
**REGISTERED OFFICE AND REGISTERED AGENT**

**TRANSFER**

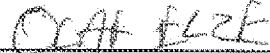
No Member of the Company may transfer the Member's interest in the Company except in accordance with the provisions of the LLC Agreement and the Act.
