TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to the provisions of Section 490.1003 and 490.1006 of the Iowa Business Corporation Act, Code of Iowa, as amended, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

I. The name of the Corporation is Fox River Mills, Inc. The effective date of its incorporation was October 1, 1983.

II. The following amendment to the Articles of Incorporation was recommended to the Shareholders by the Directors and duly approved by the Shareholders of the Corporation on December 10, 2016, in the manner required by Chapter 490 of the Act and by the Articles of Incorporation:

Article I is deleted in its entirety and replaced with the following:

The name of the Corporation is 369769 Holdings, Inc.

III. The amendment does not provide for an exchange, reclassification or cancellation of issued shares.

IV. The Amendment shall become effective on the date of filing with the Secretary of State.
