**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Termination and Release”) dated as of April 30, 2018, is made by Deerfield Private Design Fund III, L.P. and Deerfield Special Situations Fund, L.P. (“Secured Party”) to RedBrick Health Corporation (“Grantor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Intellectual Property Security Agreement (defined below) or the Facility Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Facility Agreement dated as of August 31, 2015, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Facility Agreement”), by and among the Grantor and Secured Party, the Grantor executed that certain Intellectual Property Security Agreement, dated as of August 31, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Intellectual Property Security Agreement”), which was recorded in the United States Patent and Trademark Office at Reel 005624 Frame 0459 (with respect to the Trademarks) and at Reel 036586 Frame 0081 (with respect to the Patents), pursuant to which the Grantor granted a security interest to Secured Party, in Grantor’s IP Collateral, including certain patents and/or patent applications and trademarks and/or trademark applications listed on Schedule A attached hereto and made a part hereof.

WHEREAS, Secured Party now desires to terminate and release its security interest in the Patents and Trademarks and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor’s right, title and interest in and to the IP Collateral, including those Patents and Trademarks set forth on Schedule A.

2. If and to the extent that Secured Party has acquired any right, title or interest in or to any of the IP Collateral, Secured Party hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by Secured Party, any and all of its right, title, and interest in and to the IP Collateral (including without limitation those Patents and Trademarks set forth on Schedule A), along with any goodwill in the IP Collateral that Secured Party may have acquired.




