RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated April 27, 2018 by BMO Harris Bank N.A., a national banking association ("*BMO*"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, acting as administrative agent (BMO acting as such administrative agent being hereinafter referred to as the "*Agent*");

WITNESSETH:

WHEREAS, SafeStop, Inc., a Delaware corporation ("*Debtor*"), with its mailing address at 3349 Highway 138, Building B, Suite D, Wall, New Jersey 07719, and Agent were parties to a certain Trademark Collateral Agreement dated April 30, 2015 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on August 12, 2015 at Reel 5598, Frame 0189 (the "*Agreement*"), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and


