TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of March 2, 2018, by MADISON CAPITAL FUNDING LLC, in its capacity as Agent for the Lenders (in such capacity, "Grantee"). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Assignment described below.

W I T N E S S E T H:

WHEREAS, Grantee and AIR AMBULANCE PROFESSIONALS, INC., a Delaware corporation ("Grantor"), were parties to that certain Trademark Security Agreement dated as of September 4, 2013 (the "Assignment"), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including, without limitation, the Trademarks set forth on Schedule A hereto; and

WHEREAS, the Assignment was recorded by the United States Trademark and Trademark Office on September 4, 2013, at Reel 5103 Frame 0379; and

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases, terminates and discharges its continuing security interest in Grantor's entire right, title and interest in and to the following (collectively the "Trademarks Collateral"):

a. each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

b. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the goodwill associated with each such Trademark.

2. Grantee hereby releases its security interest in and lien on the Trademark Collateral.

3. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in and to the Trademark Collateral.
