RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of May 1, 2018 (the “Effective Date”) by Royal Bank of Canada, as administrative agent and collateral agent (in such capacity, the “Administrative Agent”) for the benefit of Pre-Paid Legal Services, Inc., an Oklahoma corporation (the “Borrower” or the “Grantor”). Capitalized terms used herein but not defined shall have the meanings set forth in the Collateral Agreement (as defined below).

WHEREAS, reference is made to that certain Second Lien Collateral Agreement, dated as of July 1, 2013 (the “Collateral Agreement”), among the Borrower, Holdings, any Intermediate Parent and certain Subsidiaries of the Borrower from time to time party thereto and the Administrative Agent;

WHEREAS, pursuant to the Collateral Agreement, the Grantor and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of July 1, 2013 (the “Trademark Security Agreement”), under which the Grantor pledged, assigned and granted to the Administrative Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, the trademark registrations and applications set forth on Schedule I to the Trademark Security Agreement, along with the goodwill associated therewith, and all Proceeds and products thereof and all rights to sue for past, present and future infringements, misappropriations or violations thereof (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on July 3, 2013 at Reel 005063 and Frame 0147;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks listed under Schedule 1 attached hereto.


If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby re-assigns and re-transfers such rights, title or interest to the Grantor.

The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantor.

This Release shall be governed by and construed in accordance with, the laws of the State of New York.
