**TRADEMARK ASSIGNMENT**

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE, its successors and assigns, all of ASSIGNOR's right, title, and interest of whatever kind in and to the Mark and the Property, including, without limitation, (1) the goodwill of the business relating to the goods and services in respect upon which the Mark is used and for which the Mark is or shall be registered, (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark and/or the Property, including, without limitation, damages and payments for past, present and future infringements and misappropriations of the Mark and/or the Property; and (3) all rights to sue for past, present and future infringements and misappropriations of the Mark and/or the Property.

ASSIGNOR represents and warrants that ASSIGNOR has the power to enter into this assignment; and that the rights transferred in this assignment are free of any liens, encumbrances or adverse claims. ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary to secure, complete or vest in ASSIGNEE full right, title, and interest in the Mark and the Property.
